


Fraud and cyber crime now represent almost half of all crime in the UK




70% of frauds reported to Action Fraud are cyber-enabled







Counter fraud good practice: 7 Steps

- Establish the nature and scale of the problem
- Develop a counter fraud strategy
- Restablish an implementation structure
- Design and implement fraud prevention measures
- Design and implement fraud detection measures
- Design and implement investigative processes
 - Monitor outcomes
