MURRAY BRIDGE REBUILD AFTER DEVASTATING JANUARY 2018 FIRE


In 2018 TFI experienced the devastating loss of its jewe in the crown, the Murray Bridge Processing Plant.

The largest multi-species processing plant in Australia was totally destroyed by fire. From day one we vowed to rebuild.

In June 20 19 TFI announced the Murray Bridge rebuild.

The build is on schedule to be finished by December 2022, we expect to be operating by the beginning of 2023.
